



The heart of Ryde's business district, just 12km from Sydney CBD.

First opened in 1957, Top Ryde City has been the town centre for the Ryde area for decades. Today, the centre is a thriving mixeduse development comprising commercial tenancies, retail, dining and leisure experiences, along with seven residential towers, housing over 650 apartments. Currently, Top Ryde City shopping centre is over 76,000sqm, comprising over 280 stores, anchored by Woolworths, Aldi and Coles supermarkets, plus Kmart, Big W and Harris Scarfe.
















Floor Plan
